

HEALTHCARE OR PATIENT ORGANISATION APPLICATION FOR CAMURUS FUNDED PLACES IN THE CERTIFICATE IN THE MANAGEMENT OF DRUG MISUSE PART 1 (RCGP ACCREDITED) COURSE

As part of our commitment to supporting workforce development, Camurus is offering a limited number of funded places in the Certificate in the Management of Drug Misuse Part 1 (RCGP Accredited) (<https://www.sldtraining.co.uk/courses/certificate-in-the-management-of-drug-misuse-part-1-rcgp-accredited>), delivered by SLD Training.

Principles

Camurus funded places are available to Healthcare or Patient Organisations working in the field of addictions. This includes, for example, NHS providers, third sector treatment services, and recovery organisations. Places cannot be provided to individuals.

The provision of Camurus funded places is being made as a 'Donation' as defined in the ABPI Code of Practice for the Pharmaceutical Industry 2021. The places are a benefit-in-kind, freely given for the purpose of supporting healthcare or education, with no consequent obligation on the recipient organisation to provide anything to the benefit of Camurus in return. In particular, the provision of funded places is not linked to any past, present or future prescribing, purchase, supply, sale, or administration of a specific medicine.

Camurus is transparent in how we interact with the healthcare system. Camurus will publicly disclose each donation as a 'Transfer of Value' (£336 per place) in keeping with industry standards. We do this via the industry body disclosure portal (<http://www.disclosureuk.org.uk>). Recipients will be required to sign a Donation Agreement acknowledging the terms of the donation, including the requirement for disclosure.

Criteria and application process

Camurus has partnered with SLD Training to conduct an independent review and selection process. The aim is to distribute the places based on need, diversity of applicant organisations, and geographical reach. If applications exceed the number of available places, eligible applications may need to be declined or the number of places offered to an applicant may be less than requested.

Applications will be judged based on benefit to patients.

Completed application forms will be submitted to SLD Training for review and selection. The outcome of review will be shared with Camurus and in turn communicated to applicants. Where successful, Camurus will prepare a Donation Agreement and, ultimately, instructions for participation in the Certificate in the Management of Drug Misuse Part 1 (RCGP Accredited) course will be provided.
